Respected Madam/Sir,

As you are aware, "Technical Education" and its related aspects are controlled and governed by the All India Council for Technical Education Act, 1987. Section 2(g) of the AICTE Act defines Technical Education:

"Technical Education" means Programmes of education, Research and Training in Engineering Technology, Architecture, Town Planning, Management, Pharmacy and Applied Arts and Crafts and such other Programme (or) areas as the Central Government may, in consultation with the Council, by notification in the Official Gazette


Till date, the AICTE was regulating only the Post Graduate Programs in Management (MBA) and Computer Applications (MCA). However, from next academic year, AICTE has decided to regulate institutions offering BBA, BMS & BCA courses in view of maintaining uniform quality & academic standards across Management and Computer Applications Programs on the similar lines of Post Graduate Courses/Programmes (MCA/MBA).

As informed by the AICTE, approved Institutes have benefits like, Faculty Development Programs, Scholarship Schemes for students, Model Curriculum, Free access E-Books in Indian Languages through e-Kumbh Portal, Margdarshan Scheme for Institutions, PARAKH - Performance Analysis and Review for Holistic Development, etc.

The State Public Universities are requested to communicate the above information to all its affiliated institutions which are offering or intend to offer programmes/courses in BBA, BMS & BCA, for compliance.

Simple Steps for Existing /New Colleges offering/intend to offer BCA/BMS/BBA programmes/courses and seeking AICTE Approval for the first time

Existing / New Colleges offering/intend to offer BCA/BMS/BBA programmes/courses (Either already offering or without programmes/courses like BA, B.Sc, B.Com, MA, M.Sc etc) seeking AICTE Approval for the first time only for BCA/BMS/BBA Programs/Courses are requested to follow the below mentioned Simple Steps to obtain AICTE Approval:

- **Step-1:** Visit NSWS website at www.nsws.gov.in and register.
- **Step-2:** After successful registration at NSWS portal, login with credentials and add AICTE approval on dashboard of NSWS portal.
- **Step-3:** Now switch to AICTE web portal by clicking on "Go to Ministry Portal" icon at NSWS Portal's dashboard.
- **Step-4:** Then you will be automatically redirected and land at home page of AICTE web portal. Now, click on "Approval Process 2024-25" icon. Screen with payment details will be opened.
- **Step-5:** Click on payment button and pay the application fee of Rs.6000/- through payment gateway.
- **Step-6:** Now, update the payment status by clicking on the Update Payment Status button. Thereafter, the application will be opened.
- **Step-7:** Fill and save the details in each of the 8 tabs in sequential manner, then click on **preview button** to view the application filled and then submit the application finally by clicking on **Submit and proceed to payment button**(under 7th tab).
- **Step-8:** Pay applicable TER charges as visible in portal through payment gateway from Payment tab(8th tab). Now, update the payment status by clicking on the **Update Payment Status** button. Thereafter, application status will be updated as **Submitted and Payment Received**.
- **Step-9:** Institute can generate the **Application Reports/Affidavit** from Attachments tab by clicking on **Reports icon**.

Note 1: Payment can be done within 7 days from submission only after the successful submission

of the application.

Note 2: Institute can generate the reports from portal after successful payment made.

Note 3: Uploading of applicable documents can be done by the Institute after the submission of application.
